2. College Council's decision regarding membership of committee

The College Council has decided to follow the constitution as it reads and allow Drs. Waring and Marshall to join the Curriculum Program Committee only as tech advisors. Dr. Ritch suggested an amendment to the constitution allowing its members to change the make up of the Council as they see fit. Dean Fueyo suggested that representatives from each program be invited only when their input is needed.

5. Status of matrices of AP and ESOL competencies

The Matrices should be divided by program and display which competencies have been met. Some members questioned how their particular program would fit since the competencies only seem to apply to teacher preparation programs. One course cannot encompass all accomplished practices therefore instructors must find a way to demonstrate several, not all, accomplished practices through assignments from particular courses. Also, instructors must begin implementing these accomplished practices and competencies into their coursework and assessment procedures.
